
Please print out this page and 2 copies of the Authorization Form.

Thank you for your interest in making contributions through automatic bank drafts. We have an electronic funds transfer [EFT] program set up with our local bank which, with your permission, allows them to draw a fixed gift amount directly from your checking account each month. This saves you postage and time in writing checks. When our bank notifies us that the transfer has been made, we add the gift to your records here at Help Ministries and mail you a receipt. You may change the amount or terminate the arrangement at any time by writing to us early enough to stop the next month's withdrawal.

On the Authorization Form, please tell us the day of the month you want the withdrawal made, which area of ministry you want your gift to go to, and the amount of the monthly gift. Then please sign and fill out the bottom part of the form. Keep one Authorization Form for yourself and return the other to Help Ministries with a check. (It may either be a **contribution check OR a voided** one.) Our bank needs the codes and other information found on the check.

We appreciate so much the part you play in Help Ministries. This is important to us because these are truly critical days in which to minister to others. Thank you for your part in reaching the world with the Gospel. May the Lord bless you for it.

1. This authorization to charge my bank account is the same as if I had personally signed a check to Help Ministries. This agreement will remain in effect until I notify Help Ministries or my bank telling them I want to discontinue, and they have had a reasonable amount of time to act on it; or until Help Ministries or my bank sends me 10 days' written notice that they will end the agreement.
2. A record of my gifts will be included in my bank statement.
3. I have the right to tell my bank to reverse any transfer. This must be done in writing within 15 days of the date of the bank statement or within 45 days after the transfer was made.
4. I understand and agree that my bank is not responsible for an error in the amount of any transferred gift. Help Ministries has the right to initiate correcting entries in the event of such error. I will handle this problem directly with Help Ministries.
